RETURN SERVICE AGREEMENT

(hereafter referred to as "GASFI")

Whereas the Scholar and GASFI wish to enter into an agreement whereby the GASFI shall shoulder the tuition fees of the Scholar for a Political Science program of a local college or university and in return, the Student shall provide services to GASFI, a related company or organization partners upon successful completion of the program.

NOW THEREFORE this agreement witnessed that by their mutual covenants and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Student and the University (individually, each referred to as the "Party" or collectively, referred to as the "Parties") agree as follows:

OBLIGATIONS OF THE STUDENT:

The Scholar, having been accepted as a scholar of GASFI and covered under the RSA Policy shall:

1. Faithfully adhere to the Vision-Mission of GASFI and his/her school of choice specifically the ideals and requirements of his/her academic program;
2. Attend and participate in seminars, lectures, discussions, forum, trainings provided by GASFI in accordance with the Scholarship Program's Calendar of Activities.
3. Abide by the prescribed course of instruction unless sooner separated or dismissed by competent authority for failure to cope with the academic and/or disciplinary standards, rules and regulations.
4. Render civic services to an organization, subject to GASFI's approval, in the Republic of the Philippines for a minimum of two (2) years within five (5) years from graduation unless unable to do so due to physical and/or mental incapacities as determined by a third-party to be determined by GASFI;
5. Submit on or before December 31 of every year for five (5) years, beginning the year he/she graduated from college a report of his/her civic service activities for that year, specifying the

exact location and address where he/she is currently working, email address and landline or mobile number.

PENALTY FOR BREACH OF OBLIGATION:

1. The Scholar acknowledges and agrees that before the completion of his/her obligations under the Return Service Agreement he/ she must have volunteered and actively participated in at least two (2) GASFI activities per semester.
2. The Scholar shall be held liable for breach of contract and reimburse to GASFI twice the full amount of his/her tuition, and all other expenses incurred by GASFI, in event that he/she fails to fulfill the above mentioned obligations, for no justifiable reason as determined solely by GASFI.

ALTERNATIVE DISPUTE RESOLUTION:

In case OF A DISPUTE BETWEEN THE Parties arising from the breach by the Student of his/her obligations under this Return Service Agreement, they hereby agree to freely and voluntarily submit themselves to the necessary consultation and negotiation process for purposes of amicably settling their dispute. Should the Parties fail to reach an amicable settlement, any dispute or controversy arising from this Agreement shall be submitted to arbitration, in accordance with law (RA 9285). Finally, the Parties agree that should their dispute reach the courts of law, the competent courts of Manila shall have exclusive jurisdiction over the same.

NOT A CONTRACT OF EMPLOYMENT

The Scholar and GASFI agree that this Agreement does not constitute and shall not be construed as constituting a contract of employment by GASFI to the Scholar.
